## Progression

Students who wish to study Law at university should be aware that some Higher Education institutions require them to sit a test known as the National Admission Test for Law (LNAT) during the first term of Year 13. These universities are: University of Birmingham, University of Bristol, Durham University, University of Glasgow, King's College London, University of Nottingham, University of Oxford, University of London and University College London.
